### **GRAND RAPIDS SANTA CLAUS PARADE**

# "100 Years of Magical Memories"

# Saturday, November 23, 2019

The parade originally started in 1919 as the Wurzburg's (Department Store) Santa Claus Parade, continuing for the past 100 years with the Grand Rapids Jaycees assuming leadership in 1969. Members of the Great Lakes

Newfoundland Club have participated with their dogs since 1979 --- making this our club's 40<sup>th</sup> Anniversary of bringing smiles to the faces of the spectators along the parade route as one of the parade's favorite entries. Today, GR's Santa Parade is the second largest in the State, outranked only by Detroit's Thanksgiving Parade. We hope you and your Newfs will join us for this year's special anniversary celebrations!



Dress your Newfs and yourselves in your most

festive holiday attire for the parade and meet at the staging area by 8:15 a.m. (I will send the exact staging location to those who let me know they plan to participate when I receive them from the Jaycee's Parade Committee, by a week before the parade.) Have your Newf pull a decorated cart, if he is trained to pull one --- the crowds love it! If you choose to give treats to the children along the way, you must hand them to them --- for safety reasons, they must not be thrown. Also, it's important that you bring a supply of plastic bags in your pocket for potential clean-up at both the parade and at the park following it.



For those who plan to forego the parade this year and attend the party and GLNC meeting at the Rockford Cabin only, I will be there at 9:00 a.m. for set-up; so you can come to the Cabin any time after that. We will plan to eat around 11:30 a.m. with an auction and GLNC meeting to follow. # <u>Directions to the Rockford Community Cabin</u> 220 N. Monroe, Rockford, MI 49341

(Location of the November General Membership Meeting)

From Grand Rapids, take US-131 North to Exit 97 (10 Mile Rd. - Rockford exit). Turn RIGHT at the stoplight and go two miles. You will cross a bridge over the river and come to a stoplight.

Go 1 block past the stoplight to the first street, which is S. Monroe St., (the street where the cabin is located).

Turn LEFT on S. Monroe. After you pass through two 4-way stops (one at Bridge St. & another at Courtland St.), look for a sign on the right that says, "Memorial Park, Rum Creek Nature Trail, and Community Cabin". You will see the cabin and park in the parking lot.



Dogs are not permitted in the Cabin, so plan to securely house them in your vehicles during the after-parade activities. The Rockford Cabin is located in a safe residential area.




